

Calvin Crest Outdoor School Covid-19 Policies



At Calvin Crest, your safety is our number one priority. The following COVID-19 precautions are part of our comprehensive plan to mitigate the risk of possible exposure for our staff and guests. However, we ask all guests to acknowledge that participation in activities at Calvin Crest is voluntary. By entering our facilities and/or using equipment and activities, guests assume all risks associated with the possible exposure to or transmission of the COVID-19 virus and other illnesses. Guests on the property are asked to comply with all posted rules and requirements and staff directives; failure to do so may result in removal from the premises. The following information is designed to help you know what measures we are taking for your protection and what responsibilities you have as a guest.

Policies and procedures relating to Covid-19 safety measures may change to reflect the most current health and safety guidelines and mandates. Please contact Calvin Crest with questions.

For our Facilities and Staff:

- **Enhanced Cleaning:** All staff and guest areas are regularly and extensively cleaned, including tables, restroom facilities, recreation equipment, and retail space.
- **Cohort Model:** We will be operating with a cohort model and appropriate time between activities to facilitate social distancing and cleaning requirements.
- **Hand Washing and Sanitizing:** Bathrooms are available for regular hand washing, and hand sanitizer is at multiple points throughout camp.
- **Staff Training:** Staff have received training on COVID-19 health and safety guidelines.
- **Staff Screening:** Staff are asked not to report to work if they, or anyone they have come into contact with, are exhibiting signs of illness.
- **Staff Personal Protective Equipment:** All staff are equipped with proper protective equipment including gloves, face coverings, and (where necessary for brief close encounters with guests) eye protection or workplace barriers.

For our Teachers, Students, and Cabin Leaders:

- Please— **STAY Home** if you show any signs or symptoms of being sick.
- **Face Covering:** Under current Center for Disease Control and Prevention (CDC) guidelines, allowing unmasked members of the public into business establishments creates a health and safety risk. Moreover, COVID-19 is spread by persons who may be asymptomatic, and who possibly have no idea whether they carry the virus. As a result, guests are **required** to wear masks or other suitable face coverings indoors and during certain activities under state and local ordinances mandating masks.
- **Social Distancing:** Please maintain a 6-foot distance from others outside of your cohort. Staff will help ensure appropriate distancing.
- **Health Screening and Temperature Check:** Schools are asked to conduct a health screening prior to teachers, students, and cabin leaders boarding the bus to Calvin Crest. This may include a set of simple, health-related questions and a temperature check. Those with 100.4 or higher temperature or symptoms of Covid-19 are asked to stay home from camp.
